## GENERAL AND SPECIAL CONDITIONS OF CONTRACT

**1. Scope of work:-**

(a) This contract is for - BSHTC-Wayanad-Construction of a Rain / waiting Shelter (balance work) near entrance counter

(b) Location access: Banasura sagar Hydel tourism centre

**2. Site investigation :-**

The tenderer before submission of tender is instructed to inspect and study the site conditions and acquaint himself with the facilities including men and materials available at site, various requirements involved in the execution of work.

**3. Availability of tender forms :-**

The tender schedule with detailed specifications can be downloaded from [www.kseb.in](http://www.kseb.in) or [www.keralahydel tourism.com](http://www.keralahydel tourism.com) up to 12/03/2019 and can be submitted by remitting the cost of tender Rs 500/- (Five hundred only) +12% GST, and EMD Rs.3,000/-

**4. Submission of tenders:-**

Tenders sealed and endorsed as such with the name of work clearly written there on will be received by speed, registered post/courier service up to 1.00PM on 13/03/2019 and should be addressed to the Special officer, Banasurasagar Dam , Thariode North for the above work strictly in accordance with the specifications schedule and conditions of contract. Tenders will be publically opened at 3.30 PM on 13/03/2019 each tender should be accompanied by an EMD of Rs.3,00/- in the form of Demand Draft or any scheduled bank and Rs.500+12% towards the cost of tender form to the Special officer , Banasurasagar Dam , Thariode North . cheque is not acceptable similarly each security approved , tender is to be accompanied by an agreement , draft form of which is available with the tender documents sold . The agreement should be in Kerala Government stamp paper worth Rs.200/- and duly completed with signature of tenderer and their witness. Tender without the EMD will be summarily rejected at the discretion of the Special officer, Banasurasagar Dam, Thariode North.

**5. Acceptance of Tender:-**

Rests with the Special officer who does not undertake to accept any particular tender or the lowest one. No tender shall be considered for part of works.

6. Tenderer shall quote only a single rate in ink both in figure and words as an overall percentage below above or at the rates given in the schedule by a single entry at the bottom by scoring out irrelevant portion and attesting all the corrections. In case of



discrepancy between the rates in words and figures the former shall prevail. The erasers or other corrections should be attested by the tenderer.

7. **Acceptance of tender and execution of work:-**

Immediately after finalization of tenders, the tenderer whose tender is accepted shall be given written intimation of having accepted his tender. On receipt of this communication, the contractor shall within the period specified in the communication, deposit a sum sufficient to make up the balance of 5 % of the probable amount of contract (as accepted value) which, together with the EMD shall be treated as security for the proper fulfillment of the contract. The contractor shall execute an agreement in Kerala state stamp paper worth Rs. 200/- at his own cost and start the work to complete in all respects within 60 days from the date of acceptance of tenderer, if he fails to deposit security, execute the agreement and start the work as instructed in the documents is at liberty to enforce the conditions enumerated in the agreement attached to the tender submitted by the contractor by way of arranging the work through other agencies as contemplated in the contract agreement.

8. Right to decide the manner in which the work is to be carried out either in conformity with the specification given in the schedule of work or in deviation from the issued specification or in any other manner rests entirely with KHTC.

9. Overall percentage rate accepted and specified in the agreement shall not be varied on any account whatsoever and it shall hold good for all items executed under the contract irrespective of variation in quantity or substitution by extra items.

10. The contractor is bound to carry out all the items of work which are not included in the schedule and agreement but which are found necessary for the proper completion of the work. In the case of all extra items whereof additional altered or substituted if departmental data rates for identical items are provided for in the contract, such rate shall be applicable with the percentage increase or decrease as the case may be except on cost of materials if any supplied by the department.

11. **Availability of materials:-**

**a) Sand:** - Sand of approved quality required for the work shall be produced by the contractor, No extra charges towards collection, conveyance, washing, sieving and conveyance as it included in the rate.

**b) Rubble, Bricks and metal:** - and interlock block of approved quality required for the work will have to be procured by the contractor at his own cost.

**c) Cement,** required for the work is to be arranged by the contractor at his own cost. The material should be in accordance with the specification given.

12. **Tools and Plants :** -

Tools and plants required for the work will have to be procured by the contractor himself at his own cost out of any tools and plants actually required for the work, if

available with the KHTC may be issued to the contractor on hire as usual condition at the direction of the Special officer.

13. **Hold up of work** :-

It shall also be clearly understood that the KHTC will not be liable for any damages or compensation for hold up caused by intervention of court, labour problems or any other extraneous force beyond the control of the board.

14. The contractor shall at the time of completion of work and settlement of claims with the contractor withhold an amount equal to that claimed as compensation that may be pending with him but remaining unsettled, to be adjusted when such claims are settled document registered with the commissioner of workmen compensation.

15. Any recovery due from the contractor on account of this work or if any liability shall be made by deducting from the bill for this work and if any amount to be recovered is found in excess of the amount of the bill for this work the difference will be recovered from the security deposits (including retention amount) furnished by the contractor and if the same is found in sufficient such deficit amount shall be recoverable from the contractor under provision of the Revenue Recovery Act in the force.

16. Releasing of security amount shall be liable to be released or returned to the contractor as early as possible on satisfactory completion of the work and payment of final bill or on expiry of guarantee period as the case may be as per terms and conditions of contract.

17. **Revision of Rates** :-

No revisions of agreed rate shall not be allowed to the contractor during the currency of the contract during the extended period of contract if any.

18. **Watching arrangement** :

The contractor shall make his own arrangements for watching, lighting and protecting the work and materials at site by day and night in all days at his own cost.

19. Contractors representative:

The contractor shall be present himself or have an authorized representative at the work to receive instructions from the Engineer on behalf of the contractor.

20. The KHTC or the agreement authority or the Director, shall have the right to terminate the contract for any one of the reasons mentioned in the conditions of the contract.

21. The tenderer are instructed to attach to the tender a bounden agreement accompanying in the tender. Sample copy to which is attached to this tender on Kerala Government Stamp paper worth Rs.200/- duly signed by him and attested by two witnesses. The tender without agreement in stamp paper of proper value in the form will be rejected.
