GENERAL AND SPECIAL CONDITIONS OF CONTRACT

1. The proposed license for the horse riding to the tourists is permitted only for the area where riding is being operated, at present near the downstream and of Dam along the side of flower show ground.
2. The licensee shall use the said licensed premises only for the purpose of operating the horse riding for tourists subject to the terms and conditions.
3. The licensee shall ensure safe custody of horses and their safe keeping as per the prevailing rules in force.
4. Earlier experience of operating Horse riding with Kerala Hydrel Tourism Centre/other government agencies may count for preference.
5. The licensee shall keep the premises neat and clean
6. The licensee shall not do anything in or outside the premises which may be a source of nuisance to any one
7. The licensee shall observe or obey all rules and regulations framed or in force by the local body/state government/Animal husbandry Department or any other authority for running of the business in the locality and shall obtain all license, all permission from the concerned authority at his own expense and cost. Any damages or allegations due to the non-adherence of statutory provision will not be liable for Kerala Hydrel Tourism Centre
8. The KHTC shall not in any way be responsible during the course of contract for any accident, loss, damage etc. which may occur during the period of license and the licensee shall to pay for this
9. The licensee is to pay the license fee from the date of taking over the possession of premises in advance before every 5th of the month.
10. The licensee shall give the security deposit of Three month's license fee in case of license is awarded in his favour.
11. An Earnest Money Deposit of Rs.10,000/- (Rupees Ten thousand only) in favour of cash receipt/DD/Pay order in favour of Special officer Banasursagar Hydrel Tourism Centre, Wayanad and payable at Padinjarathara, will have to be submitted along with Tender form

12. The license will be granted for a period of 12 months. And the licensee shall arrange the riding charge at Rs.100/trips for Adults and Rs.50/trips for children.
13. The licensee shall not sublet, assign or sub contract of any description in to any management or similar arrangements with regard to the use of license premises or part these of to any person/party including, without limitation, its subsidiary sister concern-affiliate etc.
14. In case of any strike or lockout in the Kerala Hydel Tourism Centre or in the license premises or for security reasons if the licensee is unable to function or its business is affected the licensor shall not be liable for any loss which the licensee may suffer, in such an event the licensee shall not be entitled to any reduction in the license fee or any other compensation whatsoever in nature
15. In case of licensee with draws his contract on his own one-month prior notice is required
16. A Stamp paper worth Rs.200/- (Kerala Government) should be attached along with the bid for executing the agreement.
17. The duly filled tenders should be addressed to the Officer on special duty, Banasurasagar Hydel Tourism Centre, Thariode North.P.O, Wayanad through courier/Registered post/Speed post on or before 30.11.2019 1.00PM and the tenders will be opened at 30.11.2019 3.30 PM
18. Persons having indecent behavior, facing allegation/complaint etc shall not be employed as staff
19. The tenders from those who are previously black listed will not be accepted.
20. The License is required to take necessary insurance policy of adequate value required for operating the facility and shall indemnity KHTC from all damages for personnel and third party claims due to the use of the facility by tourists. The policy shall be sufficient to cover any liability for any compensation.
21. The GST should be paid by the contractor along with the license fee.
